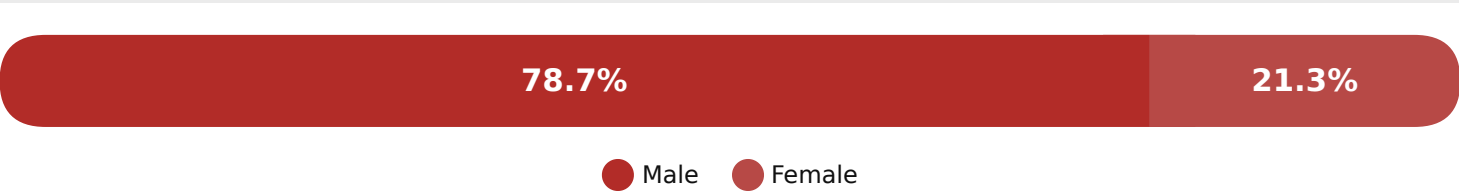

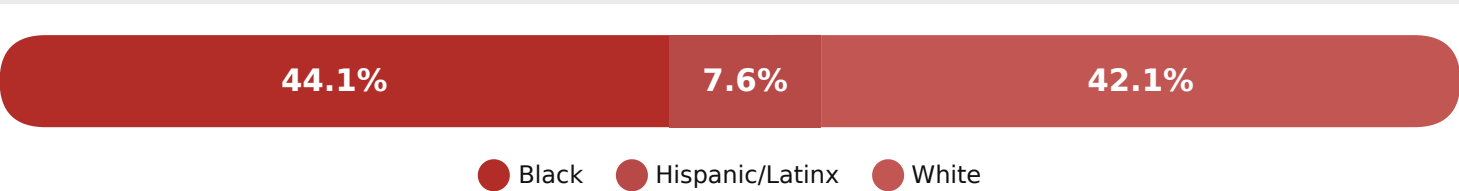

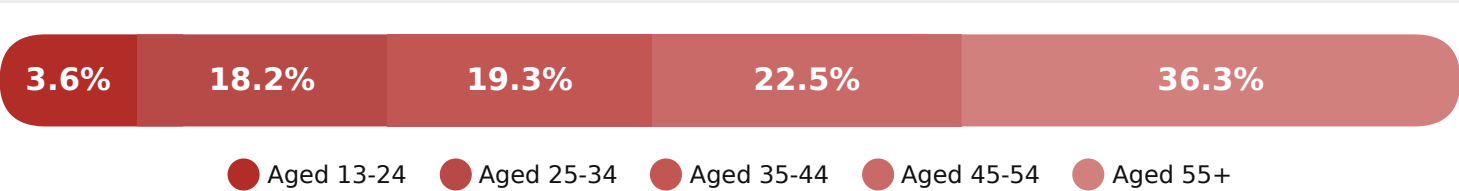
Percent of people living with HIV, by Sex, 2021



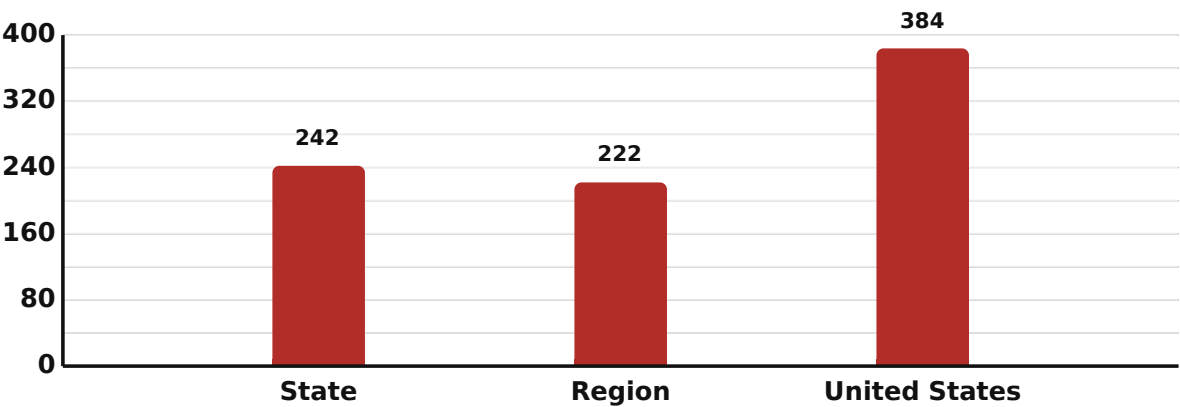
Percent of people living with HIV, by Race/Ethnicity, 2021

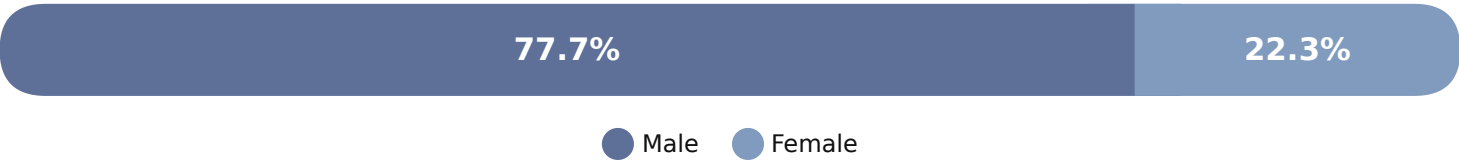

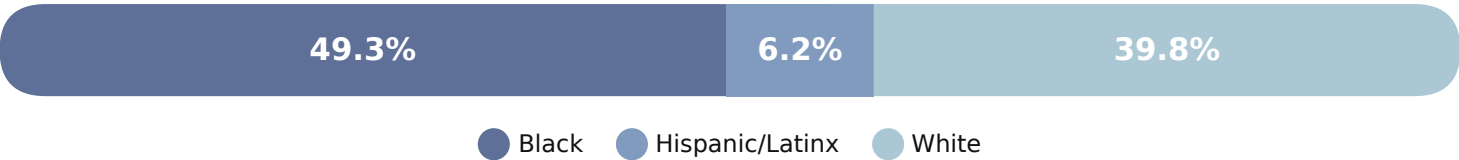

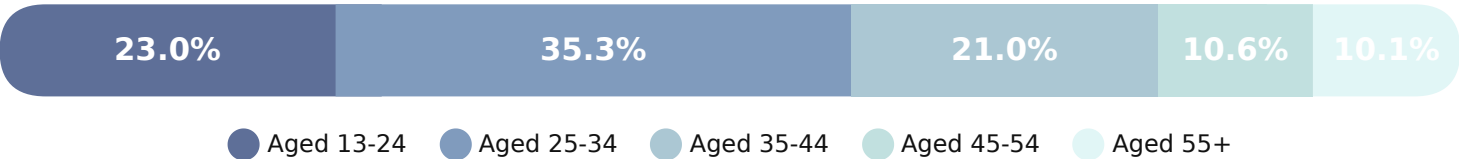
Percent of people newly diagnosed with HIV, by Sex, 2021



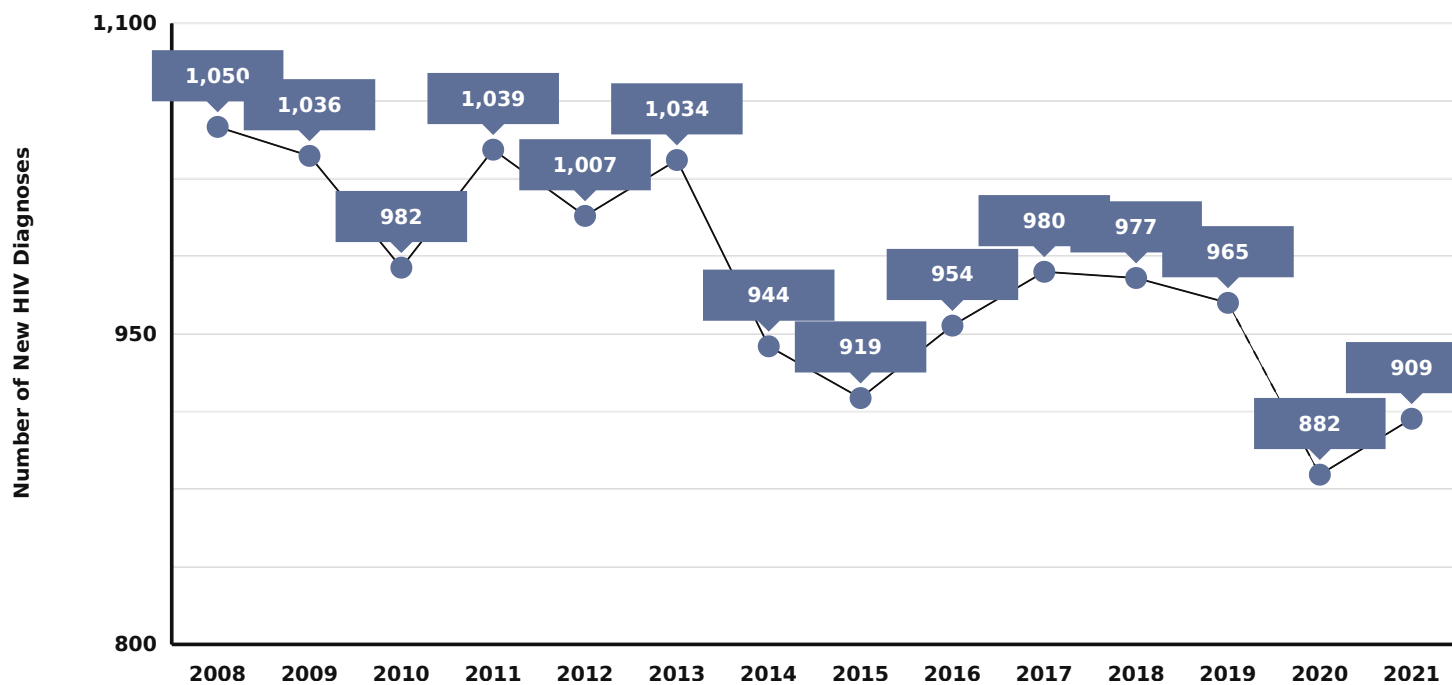
Percent of people newly diagnosed with HIV, by Race/Ethnicity, 2021



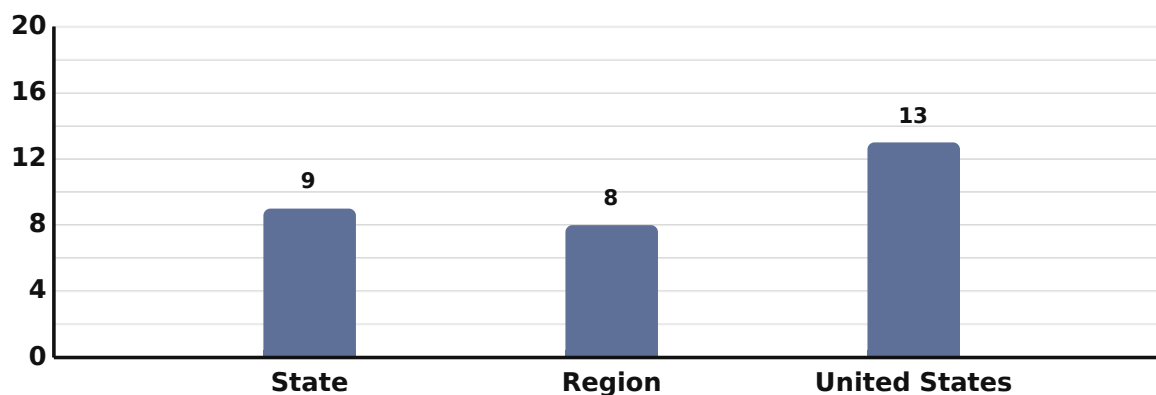
Percent of people newly diagnosed with HIV, by Age, 2021

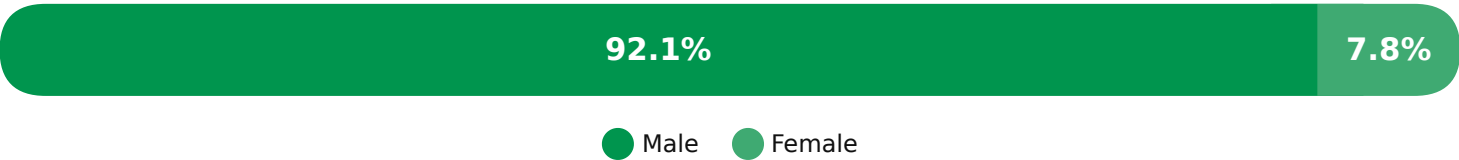

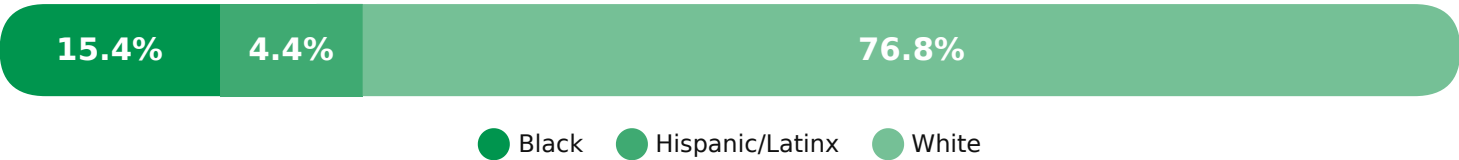

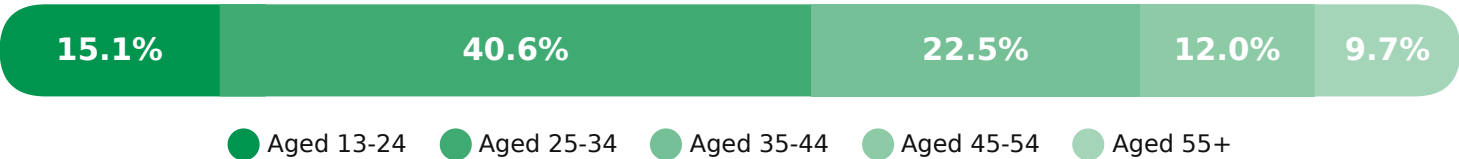
Percent of PrEP users, by Sex, 2022



Percent of PrEP users, by Race/Ethnicity, 2022

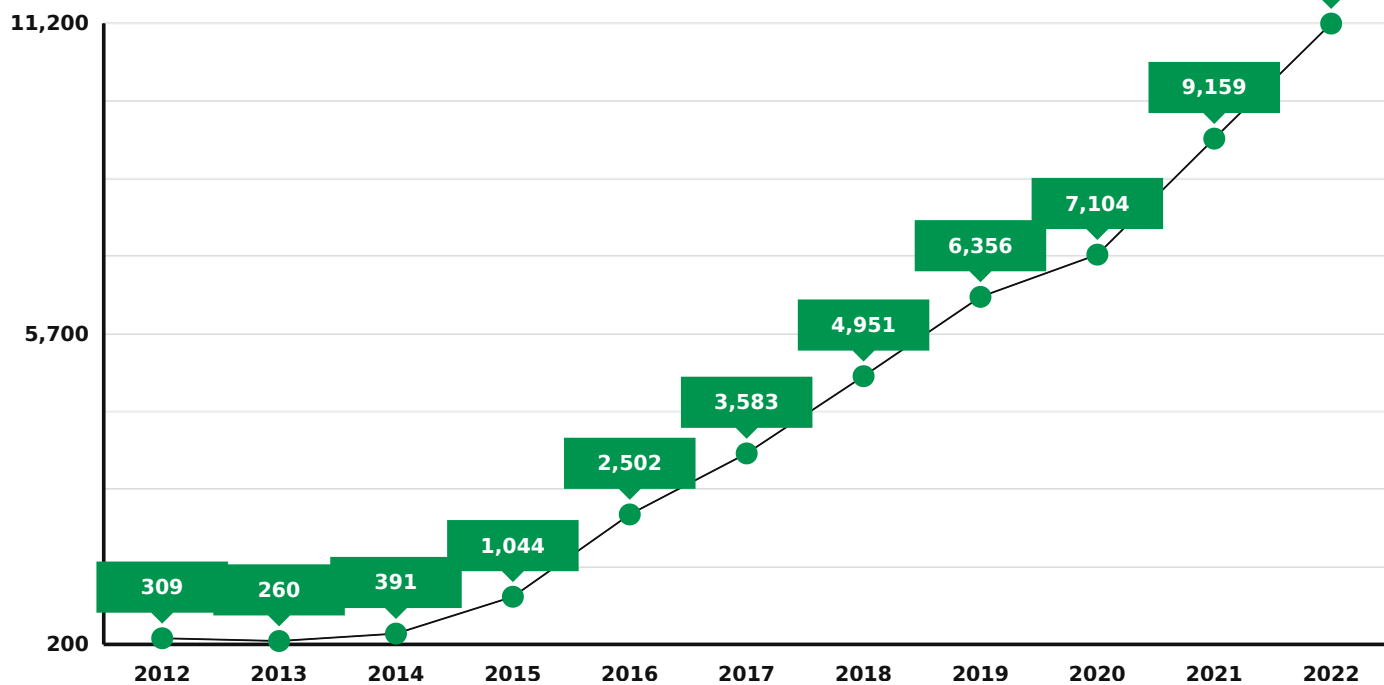


Percent of PrEP users, by Age, 2022

PrEP-to-Need Ratio (PNR)

The 2022 PrEP-to-Need Ratio (PNR) is the ratio of the number of PrEP users in 2022 to the number of people newly diagnosed with HIV in 2021. PNR serves as a measurement for whether PrEP use appropriately reflects the need for HIV prevention. A lower PNR indicates more unmet need.

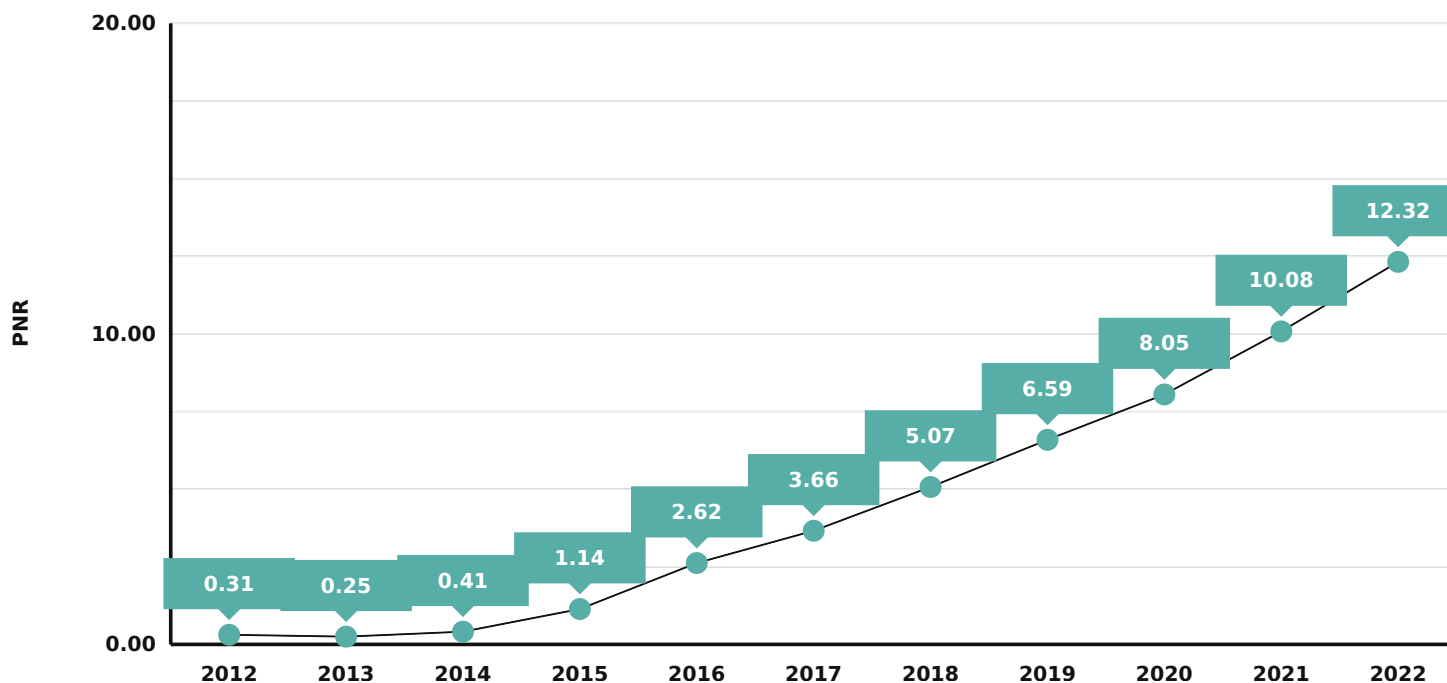

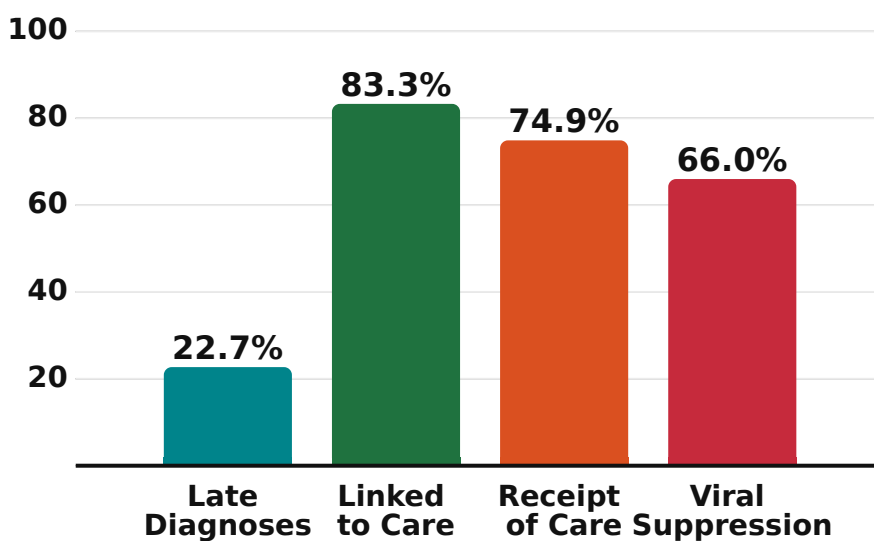

Linkage to care is defined as having a visit with a health care provider and getting a CD4 or viral load test within one month of being diagnosed with HIV.

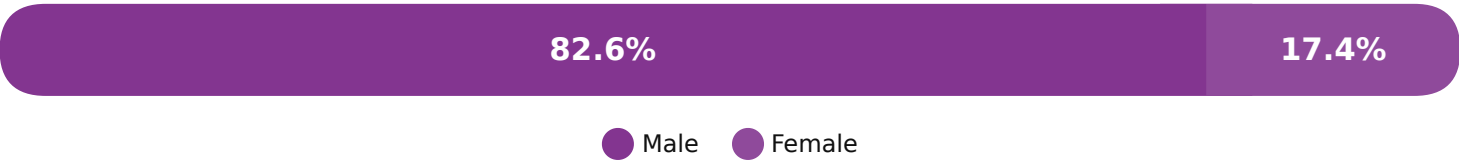

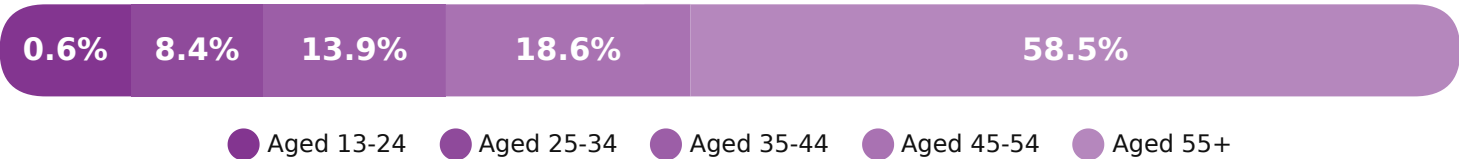
Percent of deaths of people with HIV, by Sex, 2021

Percent of deaths of people with HIV, by Age, 2021

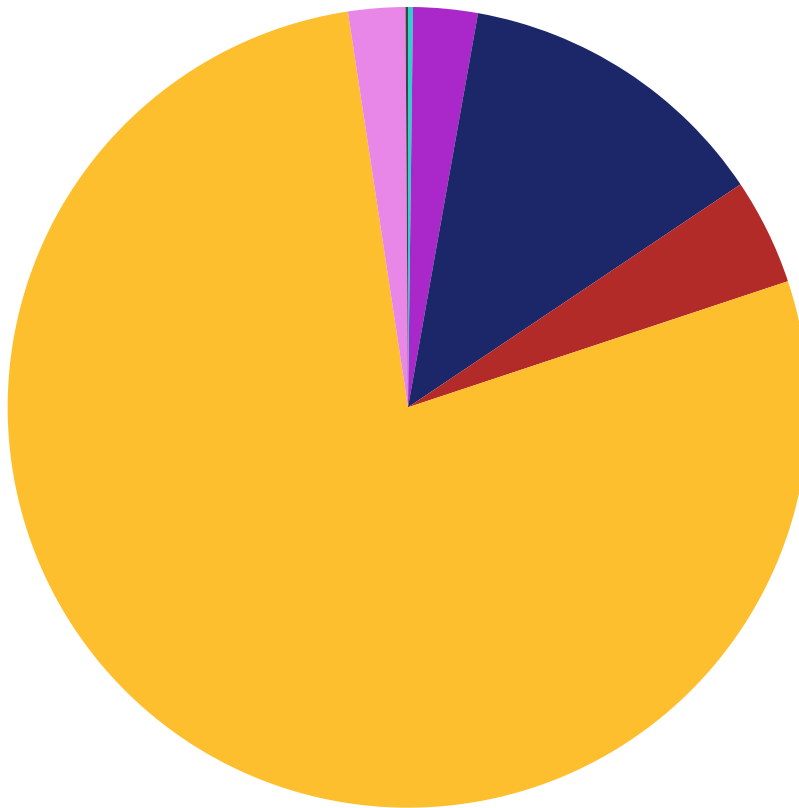

HIV Prevalence Rate Ratios, by Race/Ethnicity, 2021

The rate of **Black males** living with an HIV diagnosis is 6.0 times that of **White males**.

The rate of **Hispanic/Latino males** living with an HIV diagnosis is 3.3 times that of **White males**.

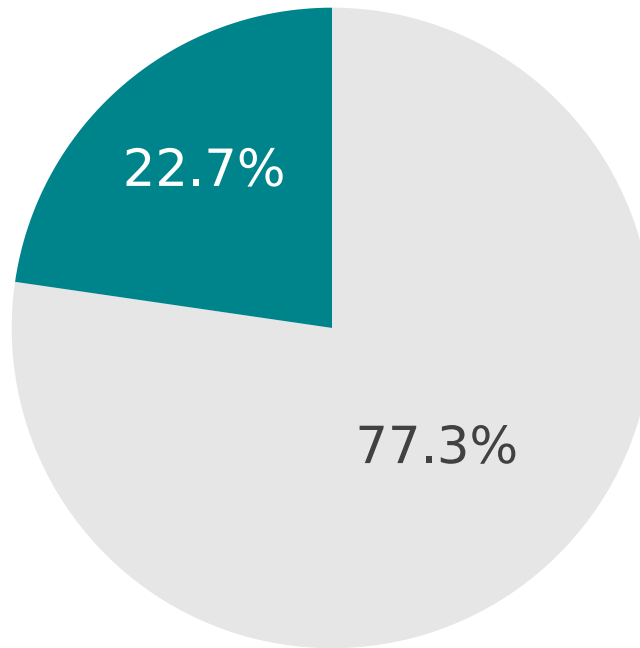
The rate of **Black females** living with an HIV diagnosis is 11.4 times that of **White females**.

The rate of **Hispanic/Latina females** living with an HIV diagnosis is 5.3 times that of **White females**.

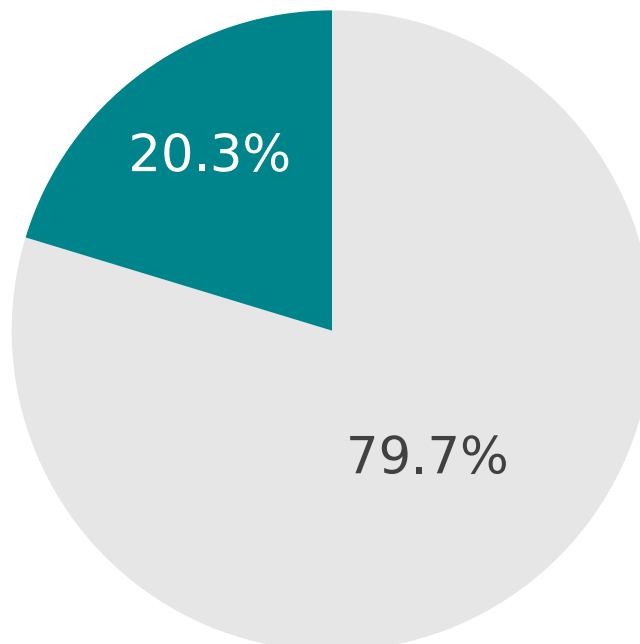

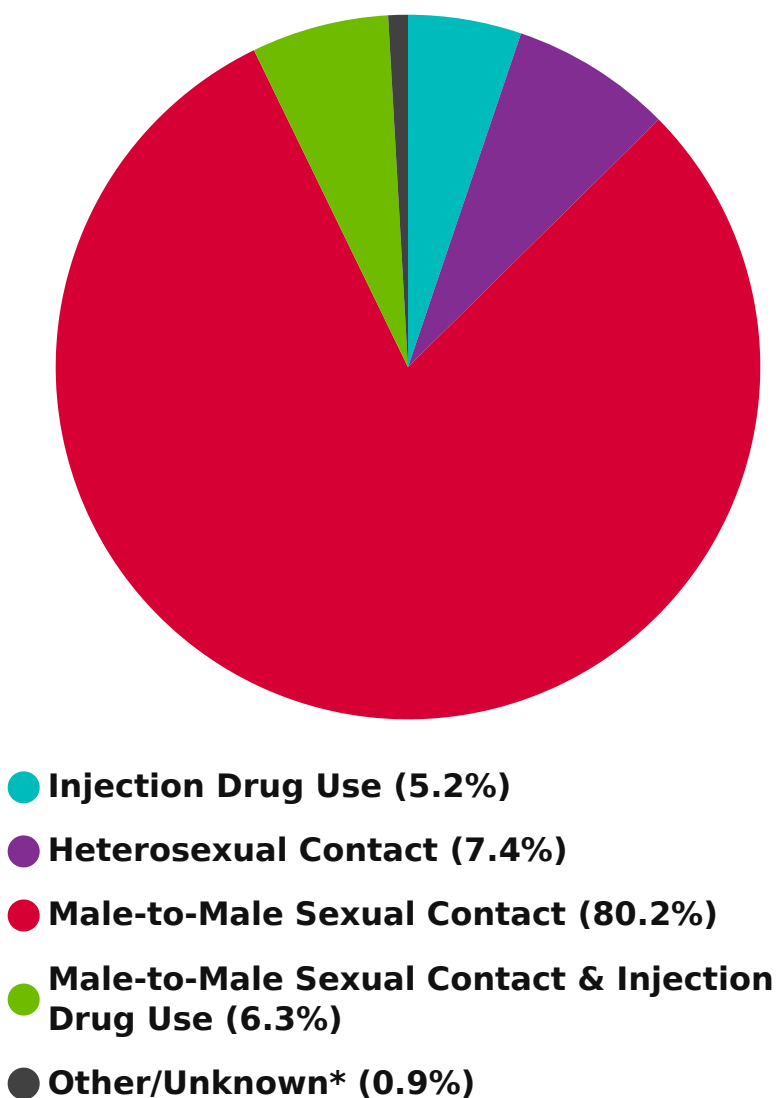

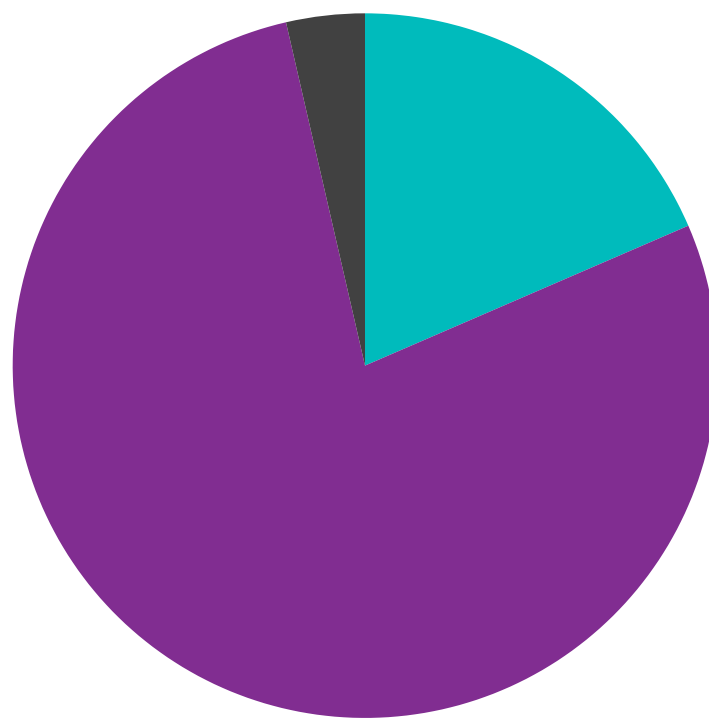
People Living with HIV, by Transmission Category, 2021

Female Transmission Categories



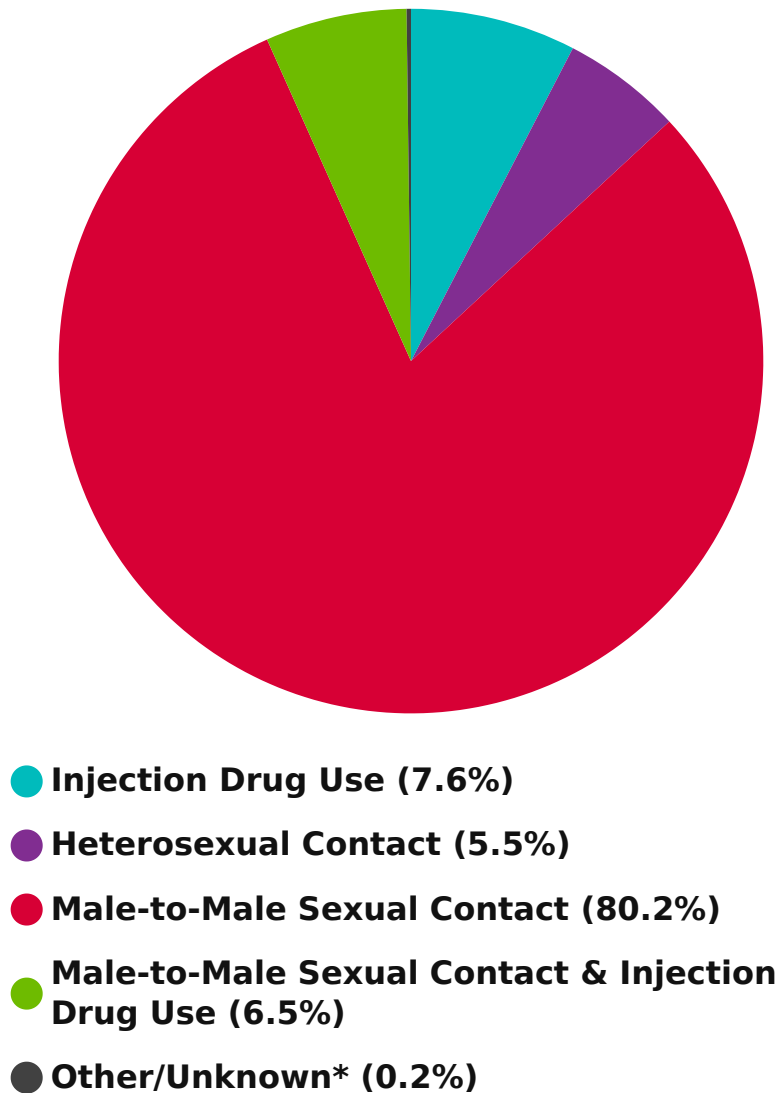

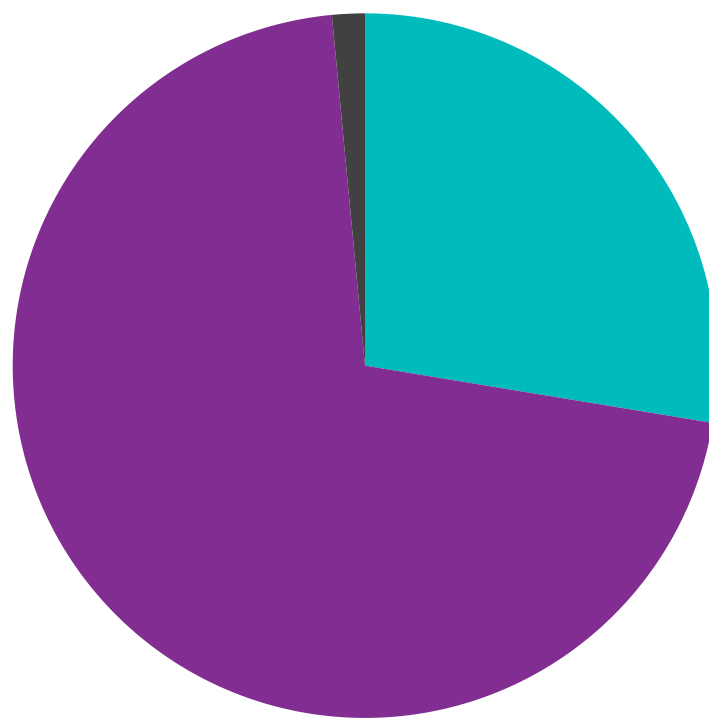

Male Transmission Categories



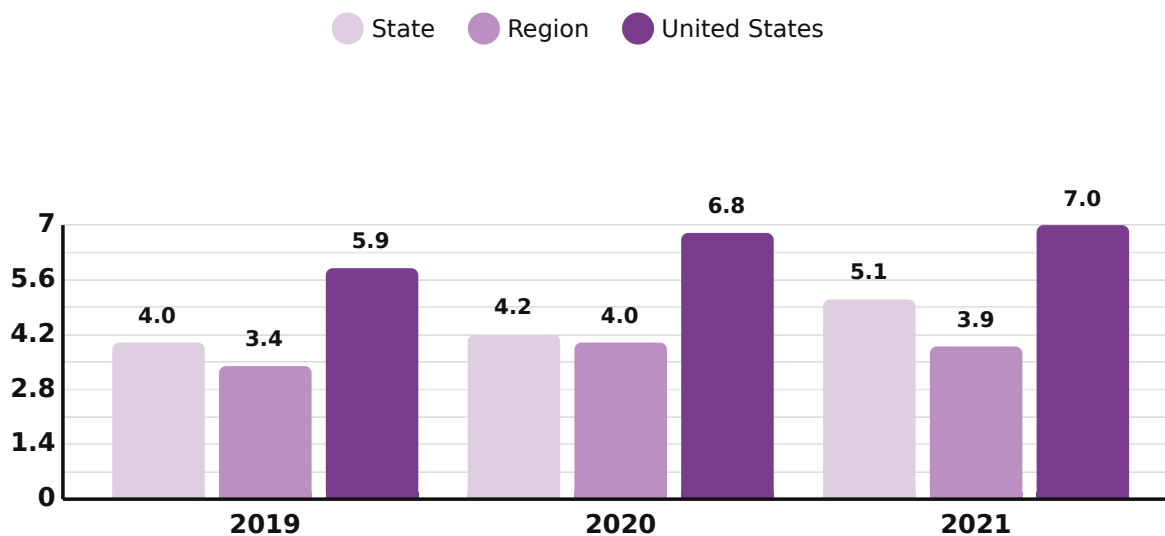

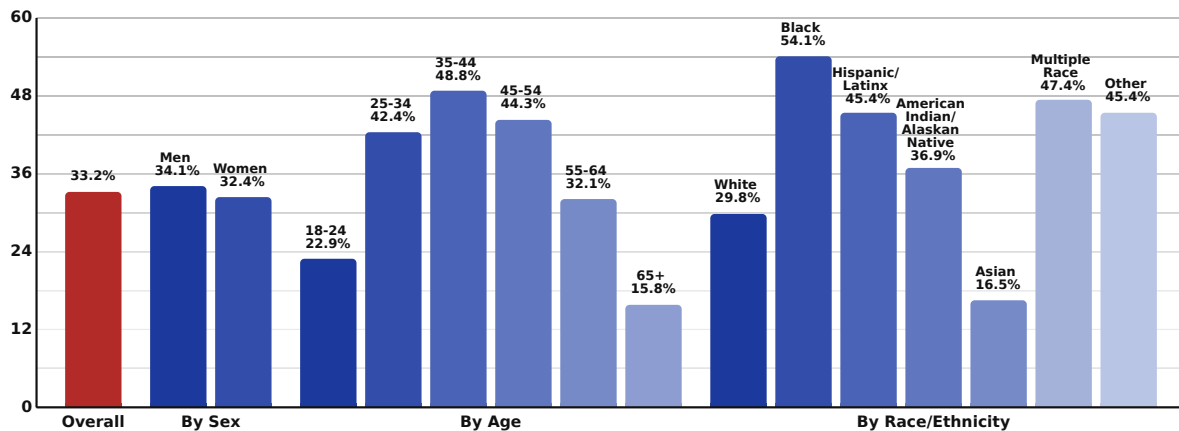
HIV Mortality Rates, 2019-2021



Mortality Rates of Persons Diagnosed with HIV per 100,000 population, 2019-2021

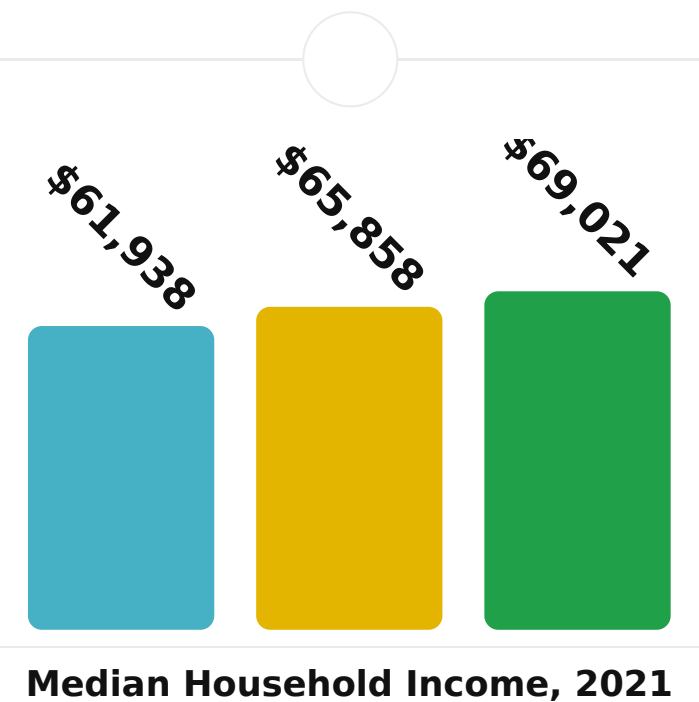
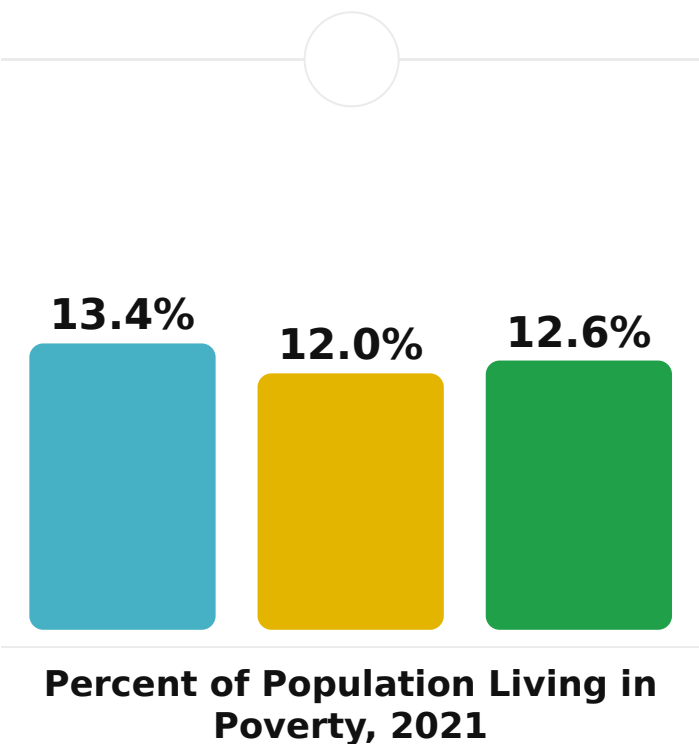
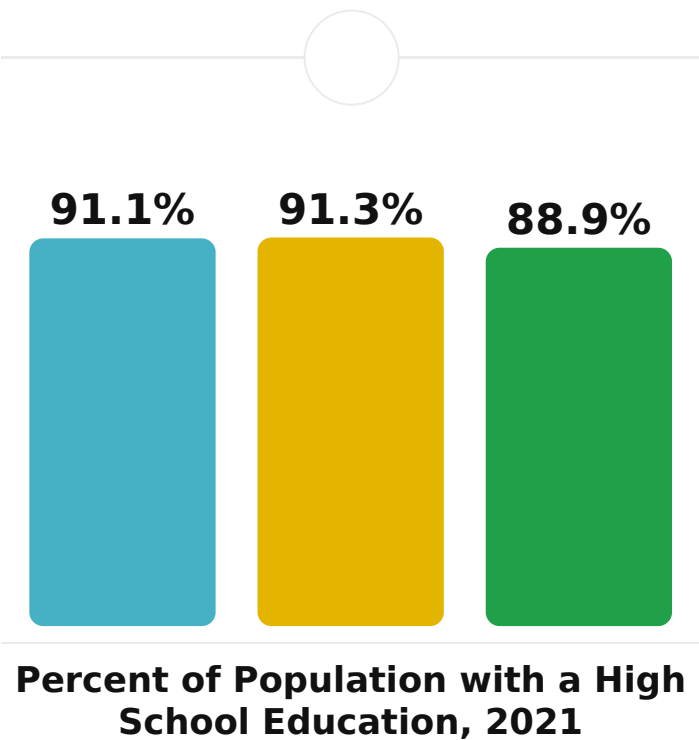

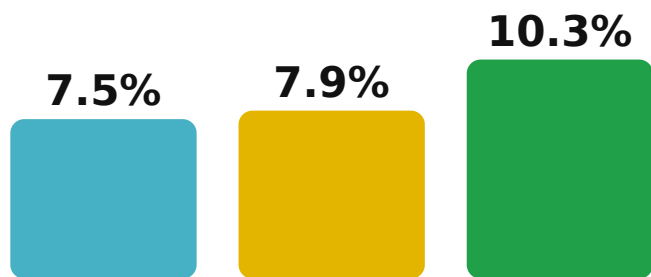

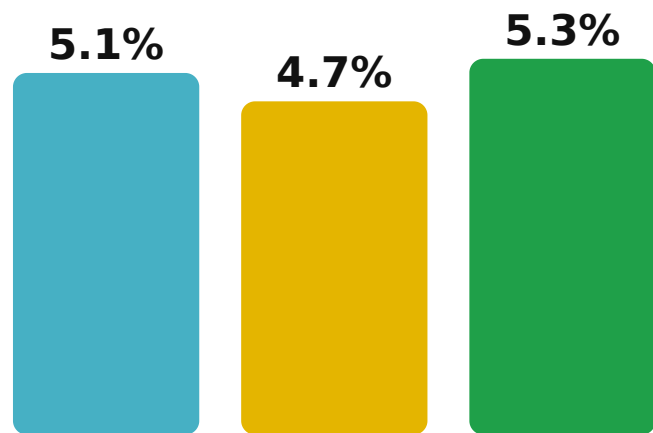

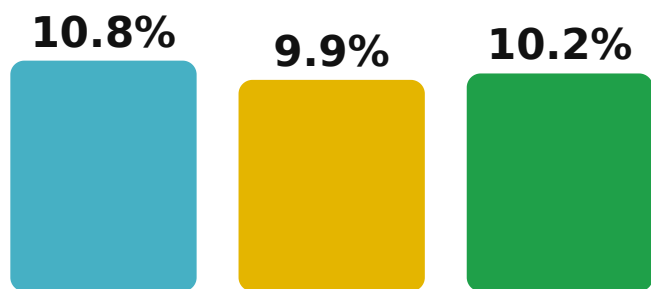




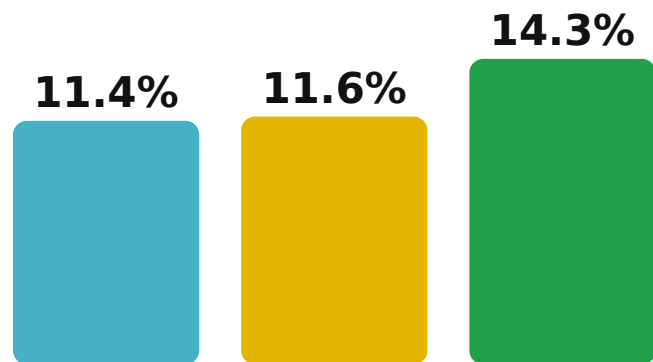
Percent of Population (<65) Lacking Health Insurance, 2021



Percent of Population Unemployed, 2021

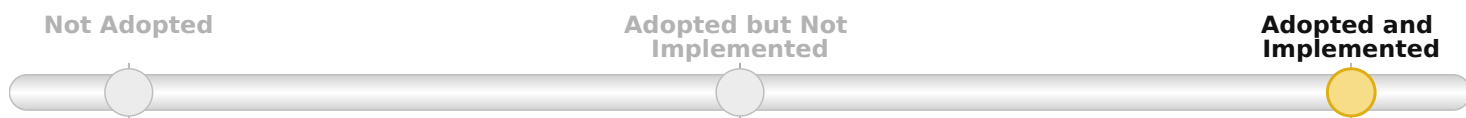


Percent of Population Living with Food Insecurity, 2021



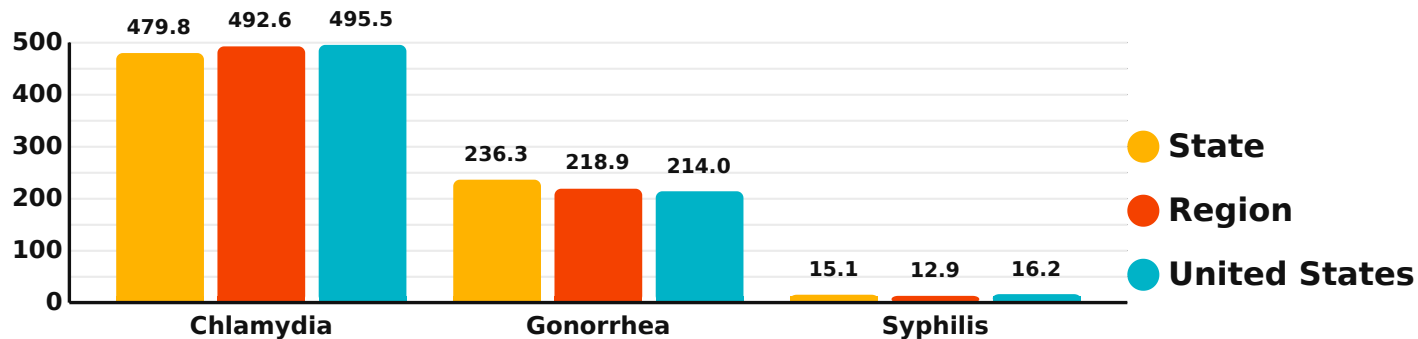
Percent of Population Living in Unstable Housing, 2021
